



Signs Of The Occult Found In Jeffrey Epstein's Mansions

DL: Yesterday was a damned good day for the cause of truth. This is Dimitri Lascaris coming to you for Reason2Resist from Montreal, Canada on February 11th, 2026. In this episode, we'll discuss new revelations regarding Jeffrey Epstein's vile associates, and I'll also share with you some disturbing images from Epstein's Manhattan mansion and his notorious island, Little St. James in the US Virgin Islands. Before I begin, please remember, if you find this video to be informative to like and share it and if you're not already a subscriber to Reason2Resist, we warmly encourage you to become one so that we can expand the reach of our unapologetic brand of resistance journalism. Now let's begin with the new revelations. Until yesterday the public did not know the identities of at least six wealthy and powerful associates of the depraved paedophile. It did not know them because the Department of Justice under the direction of Pam Bondi, with no justification, had redacted their names from newly released Epstein files. Now to their immense credit, representatives Ro Khanna and Thomas Massie, one a Democrat, the other Republican, persuaded the Department of Justice to correct their so-called error yesterday. Ro Khanna then revealed the names of these six associates on the floor of the house and here's what he had to say.

Ro Khanna: Speaker, yesterday Congressman Massie and I went to the Department of Justice to read the unredacted Epstein files. We spent about two hours there and we learned that 70 to 80 percent of the files are still redacted. In fact, there were six wealthy, powerful men that the DOJ hid for no apparent reason. When Congressman Massie and I pointed this out to the Department of Justice, they acknowledged their mistake. And now they have revealed the identity of these six powerful men. These men are Salvatore Nuara, Zurab Mikeladze, Leonid Leonov, Nicola Caputo, Sultan Ahmed bin Sulayem, CEO of Dubai Ports World, and billionaire businessman Leslie Wexner, who was labelled as a co-conspirator by the FBI.

DL: Interestingly you heard a female voice there. It sounded almost as though somebody in the house was trying to interrupt Ro Khanna just before he revealed the names. I don't know if that's in fact the case but it's possible that that's what happened and it's also possible that the speaker cut off the microphone. In any case the more important question is who are these people? Again, Salvatore Nuara, Zurab Mikeladze, Leonic Leonov, Nicola Caputo, Sultan Ahmed bin Sulayem and billionaire businessman Leslie Wexner. According to several reports, Salvatore Nuara was a member of the New York police department and served as a detective. He was previously investigated in connection with an escort service, though the investigation was not directly related to Epstein. Nuara's name is reportedly listed as a contact in Epstein's so-called Little Black Book, a directory of names and phone numbers that has been cited in multiple legal proceedings and media reports. It's unclear who Zurab Mikeladze is. The name of such an individual appears on LinkedIn. That individual is from the Georgian Republic. He describes himself as a medical doctor who currently works in oil and gas, specifically at an oil and gas terminal in a Black Sea port. But we do not know, I certainly don't, whether the individual I've just described who has a LinkedIn profile was the same individual named by Ro Khanna and the Department of Justice. Now, the other individual, Leonic Leonov, or the third one I should say, is someone about whom I've been unable to acquire any meaningful information. As for Nicola Caputo, an individual by that name served as a member of the European Parliament for Southern Italy from 2014 to 2019. And again, I cannot confirm at this time that that politician is Nicola Caputo, named by Ro Khanna and the Department of Justice. Then we come to Sultan Ahmed bin Sulayem, who is an Emirati businessman and undoubtedly a very wealthy one. Why? Because he's the chair and the CEO of DP World, Dubai Ports World, a major UAE corporation that owns and operates ports around the world. This piece of human excrement received the following email from Epstein. This is an email from Epstein on April 24th, 2009 and Epstein asks the Sultan whose name was redacted at the time this email was first published: Where are you? Are you okay? I loved the torture video. We don't know what is in that torture video, whether it's a female being tortured, a child being tortured, a political dissident being tortured, but this should shock the conscience of any decent human being. And until this day, this character, this monster, Sultan Ahmed bin Sulayem has not to my knowledge offered any explanation for this deeply disturbing email. Now bin Sulayem's name is all over the Epstein files and some of his communications with Epstein relate to Israel. So for example, there's this one from February 17th, 2010: "Dear Jeffrey, I'm attaching some media clipping regarding the Israeli operation in Dubai and I will call you around 7 p.m. Eastern Time. What happened doesn't help anyone." Interesting that he's consulting Epstein about an Israeli operation in Dubai and gently expressing criticism of the operation. Why would he direct that information or that view to Epstein if Epstein didn't have connections himself to the Israeli regime and wasn't in some way involved in the operation or at least knowledgeable about the so-called operation. What that operation was, again, I'd love to know but I don't have any information in that regard to offer you at this time.

Now DP World, the company of which this monster is chairman and CEO, owns and operates ports in more than 80 countries. To say that it is a major global player in maritime transportation would be an understatement. In Canada alone, it operates ports in Vancouver,

Fraser Surrey, Nanaimo, Prince Rupert and St. John. So from one coast to the other. And do we Canadians want a company run by this monster operating our major commercial ports? I think not. And by the way, why hasn't this character been fired or forced to resign from his position of chairman and CEO at DP World? What does it take to get axed from your job in the United Arab Emirates? As I've said many times, the UAE is little more than a Mossad operation masquerading as a country.

And this brings us finally to Les Wexner. And here you can see the ageing titan of fashion finance at the age of 88, that's his current age. Wexner, as I've previously discussed on this programme, is a fanatical Zionist billionaire. He established a large foundation to promote Israel's agenda in the United States and abroad many years ago. He has been the principal in Victoria's Secret, La Senza and Abercrombie and Fitch, among several other retail outlets. He is also the co-founder and chair emeritus of Bath Body and Works. Wexner's financial other ties to Epstein were long standing and deep. You could fill an entire book that is focused solely on Wexner's interactions and financial dealings with Epstein. As I mentioned, he's getting up there in years at 88 years old, and one wonders, is the DOJ waiting for the suspected co-conspirator to die before they finally decide whether or not to indict him? Have they even bothered to question this pervert? Those are questions which remain unanswered at this time.

Now another major revelation which came out yesterday concerned Howard Lutnick Trump's Commerce Secretary who was grilled by members of the Senate Appropriations Subcommittee on his interactions with Epstein. Lutnick's opulent Manhattan home was situated right beside Epstein's mansion in the upper east side of Manhattan on East 71st Street. Last year in an interview with the New York Post, Lutnick claimed he had met Epstein once along with his wife in 2005, when he moved into his newly renovated luxurious home beside Epstein's mansion. At that time Epstein, he claims, invited him and his wife over to the Epstein mansion for a coffee to get to know them. And Lutnick told the New York Post that in that brief interlude of time where they were interacting with Epstein he behaved in a manner that was so gross – that's the word that Lutnick used repeatedly in his interview with the New York Post last year – that Lutnick and his wife quickly left the mansion and never met with Epstein again. The phrase that Lutnick used in that interview was: one and done. He had one meeting, one face-to-face interaction with Epstein and that was the last time he ever saw the man and he was quite adamant about that. Well, the Epstein files revealed that Lutnick, like pretty much everybody in the Trump regime, is a bald-faced liar and that he had many interactions with Epstein after 2005. And certainly I would say the most eye-popping revelation is that Lutnick visited Epstein island to have lunch with Epstein. And did so with his wife and children. At this point in time, Epstein had been convicted of sexual crimes relating to a minor, and Lutnick, who said he was so gross that he refused to meet with him after 2005, years later took his children to that den of depravity known as Epstein Island. So yesterday, the world had the pleasure, the satisfaction of watching Lutnick squirm as he was grilled about this on Capitol Hill. And I'm going to show you an interaction between a Democratic Senator, Chris Van Hollen, with Lutnick relating to Lutnick's visit to Epstein's notorious estate in the Virgin Islands.

Chris Van Hollen: I think you understand the root of concern here. It's the way you described very emphatically your first encounter with him in his apartment, said you were disgusted, would never have any contact with him again. Did you in fact make the visit to Jeffrey Epstein's private island?

Howard Lutnick: I did have lunch with him as I was on a boat going across on a family vacation. My wife was with me as were my four children and nannies. I had another couple, they were there as well with their children and we had lunch on the island. That is true for an hour and we left with all of my children with my nannies and my wife all together. We were on family vacation, we were not apart to suggest there was anything untoward about that in 2012. I don't recall why we did it.

DL: I just almost fell off my chair when he stressed that he left with all of his children as though he was rendering some public service by not leaving one or more of them behind with this sick psychopath, Jeffrey Epstein. Again and again, this, by the way, I commend to you the entire grilling, it was quite something to behold, he said he protested, Lutnick, that he did nothing wrong. But at no time did he actually deny that he had lied through his teeth. According to the people in the Trump administration, lying through your teeth about your interactions with the world's arguably most notorious paedophile who also appears to have been an agent of both the Mossad and the CIA, lying about that to the American people emphatically and unequivocally through your teeth is not wrong. They don't think there's anything untoward about grotesque dishonesty. That in itself is wrong, Mr. Lutnick, but the fact that you lied about this particular subject makes it especially wrong. And the real question which all Americans ought to ask is: Why did he lie so flagrantly about his interactions with Jeffrey Epstein? What is Lutnick hiding? And you cannot count on Donald Trump to force Lutnick out of office in connection with these lies because Donald Trump himself is even more compromised probably than Howard Lutnick. I suggest we're going to be stuck with this clown, Howard Lutnick, as the Secretary of Commerce in the Trump regime for some time, unless he himself becomes so humiliated, embarrassed and discredited in his own mind by his lies that he finally does the minimally honourable thing and exits the Trump Regime, something he should have done long ago for reasons that are completely unrelated to his grotesque dishonesty.

Now, in the last 24 hours in related news the yoga and meditation celebrity Deepak Chopra had to deal, was forced to deal with the fallout of his scandalous communications with Epstein. And here is just a sample of those communications. You see here an email, at the top dated February 25th, 2017 from Chopra to Epstein, subject: I have an idea. And he wrote: "Come to Israel with us, relax and have fun with interesting people. If you want to use a fake name, bring your girls, it will be fun to have you." But it doesn't stop there. And again, I'm not showing you all the communications between this depraved meditation guru and the paedophile. But then on March 8, 2017, he wrote, Chopra, to Jeffrey Epstein: "God is a construct, cute girls are real." Now within the past 24 hours, Chopra was confronted at an airport by a reporter relating to his interactions with the twisted raper of children, and here's what happened.

Journalist: Mr. Chopra, sir, how are you? Sir, I've got to ask you, listen, Sir, you've built your entire career, you've built your entire career on spirituality. What do you have to say about your actions with Epstein? Any regrets? Do you have any regrets? I said, do you have any regrets about your relationship with Epstein?

Deepak Chopra (DC): You decide.

Journalist: What's that? You want me to decide? No, I'm asking you, Sir.

DC: Look at me and then you decide. You have a right to your opinion.

Journalist: Look, I am asking you. I am asking you, Sir.

DC: I am not answering.

Journalist: When did you know the scope of Epstein's actions, Sir?

DL: OK, so that goes on for some time, actually. Again, quite satisfying to watch. At the end of it, of course, like all of Epstein's psychopathic close associates, Chopra denies any wrongdoing. And simply, those emails that I showed you right now, not to mention others in the Epstein files, how does that not constitute wrongdoing? Unknown paedophile, you're sending him emails saying God is a construct, but cute girls are real and join me in the genocidal Israeli entity with the girls. How is that not wrong? Really, the people we're talking about here have no moral compass whatsoever and they just seem so incoherent and disoriented when they're confronted by somebody who has a basic sense of human decency, minimal decency and asks them to account for their deranged behaviour. And what I think this video shows is that to a degree we ourselves can impose at least some significant accountability on all these vipers from Epstein's inner circle. We can do that by shaming them at every opportunity. If they show their face in public, shame them relentlessly. You don't have to threaten them. You don't have to use obscenity. You don't have to shout. Just confront them with the awful facts and insist politely even upon an explanation until they run off and hide in some dark corner. That in and of itself can make a life quite an unpleasant experience for these people, especially if they're accustomed to the adulation of the public as undoubtedly Deepak Chopra is or was. And so I commend to you or I suggest to you that we collectively, despite the abject refusal of the authorities in Canada, the United States and other Western countries to prosecute all of these people, we can at least impose some degree of accountability on them by shaming them relentlessly.

Now, I'd like to move to my review of photographs of Epstein residences. Last week, I began reviewing the data set of one of the Department of Justice's Epstein files. That data set consists of photographs of Epstein's residences, not all of them, but at least a couple of the major ones, including the Epstein Mansion in Manhattan and the Epstein island residence, a palatial residence consisting of many acres on an island, a small island in the Virginia US Islands called St. James Island. I first reported on Epstein's New York mansion photographs a few days ago. At that time, I had reviewed 1200 of the photos in that database. I believe there's some 38/3900 photos in total of that database, and because all the 1200 that I had

reviewed were of the mansion, I assumed that the entire set of photographs was from the New York mansion, but I discovered as I continued my review that the photographs taken of the New York mansion stop at photograph 1500 and from that point onward, they are photographs taken of Epstein Island and the residential complex there several months after Epstein was arrested in mid 2019. I shouldn't say several months, he was arrested, I believe it was in June or early July, and the date on the FBI notice that was affixed to the entrance to Epstein Island, indicated that the investigation or the search of the premises took place on 8-12-2019. So that could mean August 12th, it could mean December 8th, but even if it does mean August 12th, I really struggled to understand why the FBI waited weeks before it searched the most notorious residence in the Epstein portfolio of properties. Because from the time that they arrested Epstein, it would have been known to his associates that he had been arrested and his confidants, and it's entirely possible that any of them who had access to Epstein Island would be tempted to go there and to cleanse the island, sanitise the residents of any incriminating evidence, particularly if it related to them. So I don't know what possible excuse the FBI could have for not immediately searching all of these premises. They certainly have the resources to do it at the time that they arrested Epstein, but nonetheless, I did find in my review thus far a number of highly incriminating photographs found at Epstein Island and recorded in the photograph that the FBI investigator did on that day.

Now I'm not going to get too deep into those photographs in this particular episode, what I want to focus upon are photographs which in my view offer hints that Jeffrey Epstein may have been involved in Satanism or a cult. And so I had identified two or three photographs of that nature when I got up to photograph 1200, but when I continued and reviewed the other 300 photographs of the New York mansion, I found a couple of other very interesting details. Before I show you those photos, I need to remind you about an excerpt from the book of the late Virginia Giuffre, an Epstein victim who died tragically last year. The authorities who can't be trusted say that she committed suicide, but in any event she's no longer with us. And in her book, published posthumously I believe last year, she said Epstein had a dungeon, that's the word she used, in his New York mansion in which she was tortured and detained for extended periods of time. And she said that there were lewd photographs of her and another minor having sex; Large photographs affixed to the walls of the dungeon as she called it. Now I can't say for sure which room in the enormous 42 room mansion in the east side of Manhattan she's referring to but this room that I'm about to show you caught my eye. And here you see a photographer, a photograph taken at the bottom of a stairwell that leads up into a rather eerie space. And in this photograph, I draw your attention to the following. First of all, in the lower right hand corner, as you can see, there's a statue of a naked woman. I believe that that is intended to depict the Greek goddess Aphrodite. And then to the immediate left of that, there's a much smaller statue on the handrail leading up the stairwell. That, too, appears to be a naked woman wearing a robe. And then if you look in the upper half of the quarter, you'll see on the left side and what appears to be a candle, it might be an electronic candle, but a candle nonetheless. And then the bookshelf in the centre at the top, beside the top drawer or shelf of that bookcase, on each side, there is what appears to be an electric candle. And then on the right side, just above the head, of the statue of Aphrodite, another candle. Now, as you continue up this stairwell or as the FBI photographer continued up the stairwell,

they encountered something that looked very much like a crystal ball and there it is. That's obviously not intended to provide people with something to grab onto while they're climbing up the stairs, a wooden handrail would be sufficient for that purpose. What that thing is doing there and whether it was actually used for occult purposes of course, I don't know, but that certainly is an interesting image to say the least. And then as you continue a little further up the stairwell, the FBI photographer found this image on the wall. This could be, this framed image, an image with occult significance. Now, I've done whatever research I can do relating to that image, I have not been able to confirm that it has any occult significance, it has any meaning known to those who are practitioners of the occult or devotees of Satanism. If any of you out there, and I'm going to come back to this later on, can shed some light on the significance of this drawing – it may have no significance, it may be just some thing that some artist, maybe Epstein himself, doodled one day and Epstein thought it was interesting or attractive as an image and put it up on the wall for reasons that have nothing to do with the occult or Satanism, on the other hand, it may have some kind of significance relating to the occult or Satanism and if you think you can shed any light on that, I'm going to tell you at the end of this report how you can share your views or your information with us on that and related subjects. All of these intriguing details caused me to take a closer look at that bookcase on the stairs leading up to a room, which I'm going to show you in a moment. And the first thing that I noticed upon looking more closely at this bookcase is that there is a book which appears very much to have the word Lucifer on the cover. You can see the placement of that book here. I've circled it in red. And I then enlarged the photograph so I could get a closer look at this and confirm that it says Lucifer on it. And this is what I saw. The images right in the second shelf, immediately to the right, the book with the word Lucifer on it, it's immediately to the right of the thick book with the title Ghost Towns of the West. I tried to find this book mentioned or described online so I could get some idea about its content. It's possible that it's just a fictional work which doesn't constitute evidence of any kind of Satanism or occult practises by Epstein, we'd need to know a lot more about this book to understand what evidence, if any, it provides that Epstein had those kinds of inclinations. I simply wasn't able to find any meaningful information, nothing reliable, because as you can imagine, there are a number of books out there that have the word Lucifer in the title, and I can't tell from this image who the author is. I don't even know if the name of the author appears there on the screen. You know, when I blow it up, the resolution becomes so poor that I can't read the wording. Now again, if any of you is able to shed light on what other words appear on that book, the part of the book that's visible here on the screen, I'm going to tell you at the end of this video how you can share that with us. I also think it's worthwhile, it can be enlightening, to try to identify the names of all of these other books. A lot of them are simply of no interest, but you may get clues into the lifestyles and the practices of Epstein and his associates by looking carefully at the books that were conspicuously displayed around Epstein's New York mansion.

Now, when the FBI photographer arrived at the top of the stairs, this is what they countered. You can see here a very dark room and there are candles. The only light in the room at the moment that that photograph was taken were from these candles, which do appear to be electronic candles, but nonetheless the choice of decor is interesting, shall we say, particularly

in light of the other hints that Epstein may have been attracted to the occult or Satanism. I did find two other indications of an interest in the occult or Satanism, not at the New York Mansion, but rather in the review that I've conducted thus far of the photographs that the FBI took at Epstein Island. And I think I'm a long way away from having completed my review, but I just wanted to share with you what I found thus far. So in the main study, what appears to have been the main study for Epstein at Epstein Island on a desk, the photographer recorded this little sculpture, which appears very much to me to be a winged demon. And then there was this photo in the collection of photos I reviewed thus far, this is a piece of paper on which perhaps it was Epstein, but I can't say for sure, scribbled a bunch of notes, some of which are illegible. And what I found interesting about this is the logo at the top. You'll see LSJ in what appears to be a compass. LSJ, I believe, means Little St. James, the name of the island that Epstein purchased and had this sprawling den of depravity built upon. And I did some research into the significance of the image of a compass and it can have, but not necessarily, it can have occult significance. And again, I'm no expert in this area. If anybody else can shed light on this, please feel free to share your insights with us. And now before I leave this particular photo, I just wanted to point out some of the things that appear to be scribbled on it; not sure what it all means. The upper left hand corner that looks like the word estate and then going down the left side of the page it looks like pinto In the top half of that page on the left side underneath that the word biz, then underneath that word tent and you'll see to the left and a little bit down of the word tent the word leon. And I wonder whether that is a reference to Leon Black. Under the word tent, there's karim. Now, under the word leon, it looks like the word children, although I can't tell because this writing, handwriting is quite difficult to make out. And if you look on the right side, you can see a number of other names that have been scribbled in the lower right-hand corner. And then there are odd symbols and numbers that have been crossed out. What all of this means, I don't know folks, but I do wonder to what degree the FBI has attempted to piece together the pieces of this rather complex puzzle, including pieces of evidence such as this, and whether they've done even a meaningful investigation into the voluminous documentation that they found at Epstein's residence. I'm only showing you a tiny fraction of that here.

Now let's be clear about what all of this means at least in my opinion. I've not yet seen definitive proof that Epstein was a Satanist, but certainly these images and other pieces of evidence that have emerged raise a serious question about Epstein's possible involvement in Satanism and the occult, and certainly his conduct can reasonably be described in the broad sense as satanic, and by that I mean as unspeakably evil. I'm just going to show you one photo to really hammer that point home. And before I show it to you, let me say, this photograph is not on the DOJ website. Apparently it was taken down. It was provided to me by somebody whom I consider to be a reliable source and who ensures me that it was published initially by the DOJ, but apparently was taken down because it is rather disturbing. It's a photograph of Epstein and a child, a female child, in a very troubling and compromising position. Now the child, you can't see her face, and the child is dressed, and although what Epstein does in this photo or is doing in this photograph is very troubling, he, himself, is fully clothed. So I just want to warn you about that if you don't want to see the image, but I think it nonetheless is important to show because it gives us a hint about how young his victims were

and how depraved this man and his entourage were. So here is the photo and I don't know exactly what Epstein is doing with his mouth, but that is clearly a female child and if I had to guess I would say that child is no more than seven or eight years old. Now let's bear in mind that initially the DOJ was saying that the victims were as young as eleven or 12. Now I've seen acknowledgements very recently from the DOJ that they were as young as nine. I don't know whether this girl was even that old. And when I get around to showing you, when I've completed my review of the documents from the Epstein Island, I should say, I'm going to show you some photographs, although the faces have been redacted, which seemed to show quite clearly that Epstein had an obsession with girls that were even less than nine years old. And there's been plenty of other indications of that in the documents that have been revealed thus far. So in any event, there is a serious question in my view about whether Epstein was a Satanist, and that question merits further investigation.

And that's where you come in, my friends. The Epstein scandal has given birth to an amazing phenomenon. I call it the People's Bureau of Investigation or the PBI. And here you can see up on the screen, we've taken the liberty of modifying somewhat the logo of the Federal Bureau of Investigation, which has utterly disgraced itself in this ongoing scandal. And what do I mean by the People's Bureau of Investigation? I mean that citizens of conscience from all over the world, not just from the United States, but from all over the World have invested significant amounts of time and energy and collaboratively communicating with each other, applying whatever special talents they happen to possess in order to make sense of this mountain of evidence and in a grand effort and a collective effort to bring these monsters to account, once and for all. And at least to begin by exposing them and then applying pressure on the authorities to impose some meaningful penalty upon them for their heinous crimes. So we say to you that anyone who is willing to participate in this grand collective enterprise in which so many people of conscience around the world have joined, since these documents began to be released, and anyone who's willing to commit some time and energy to the cause of truth in the Epstein scandal and to employ whatever skills they possess in that regard, we welcome your input and we encourage you to send us your insights, any information, additional information you can provide which can help us make sense of all of this. Not just with respect to the question of whether Epstein and his associates were involved in Satanism or the occult. And in closing, my friends, as many of you will know, Netanyahu, the bloodthirsty war criminal and murderer of children, is meeting with his fellow war criminal Donald Trump today in Washington. And I think we can expect that whatever emerges from this, their

seventh meeting in Washington since Trump returned to the White House, whatever emerges from it will be designed, at least in part, to bury the Epstein scandal to the best of their ability. This is, in fact, as I discussed on a previous episode of Reason2Resist, what happened the last time Netanyahu came to Washington. You may recall that on December 21st, pursuant to the Epstein Files Transparency Act, the Department of Justice did its first dump of Epstein files after telling us there was nothing to see. And then from December 21st until the end of December, I should say, the public discourse in the Western world was utterly dominated by revelations emerging from the publication of that documentation and all of that changed from the moment that Netanyahu left Washington. You know, ICE went crazy and murdered two peaceful Americans. Non-violent Americans who were simply protesting in a non-threatening manner, the criminal activity of those fascist thugs from ICE. There was the kidnapping of President Maduro, the Venezuelan president, on January 3rd. There was all of the chatter about the confiscation of Greenland and the big drama at Davos, where Trump basically climbed down from his maximalist position on Greenland. There were the riots in Iran which erupted late December, early January. It was shortly days after Netanyahu left Washington that the riots turned quite deadly in Iran. And as we know, Pompeo, former CIA director in the Mossad itself, said that the Mossade was involved in those riots. And then, of course, there was the sending of this armada, as Trump calls it, to West Asia to threaten Iran with another criminal war of aggression. So all of that consumed the public discourse until January 30th, when the DOJ published another round of documents, this time in excess of 3 million pages of highly incriminating documents. And we're just beginning, all of us who are investing time and energy in this to make sense of them. So, as I've postulated in a prior episode of Reason2Resist, I think one of the goals of this most recent meeting, today's meeting between Trump and Netanyahu will be to find a way to bury this story. If they're not just gonna talk about Iran, they'll surely talk about that quite a bit, but this must be of the utmost concern to them. Please don't let this story get buried. The scandal is far too important. We have only begun to penetrate it and its importance derives from the fact that it ensnares the most powerful people in the world, both from the political and the economic realm and even from academia and from the entertainment industry, highly influential people, highly powerful people, people who ultimately pull the strings and exert enormous influence over the quality of our lives and the lives of our children and the future of humanity, frankly. So getting to the bottom of what they did and who they really are, you cannot overstate the importance of that, and we have to keep the pressure and the investigation front and centre in the public's mind in the weeks and months ahead until we finally have justice for the victims of Jeffrey Epstein and his criminal associates. That's all for now, I'm signing off from Montreal on February 11, 2026.
